

# FROM THE PERSONAL REPRESENTATIVE:



irst, let me apologize for taking so long to get out the first *Rite Words* for this year. When I took over in January there were several issues that had to be dealt with right away. Ill. Bro. Atchley's illness caused some

projects to fall behind and catching them up has been an effort ... but our progress is steady.

I want to thank Ill. Bro. Jeff Horton, 33° for taking over as General Secretary in a time of crisis and Lynn Jager for assuming the duties of Special Events Planning and Building Rentals after Peggy left.

To update you on our projects, the one that has caused the most distress is the brick fund-raising for the Cathedral Foundation. While over 350 bricks were sold, it appears that the money was used to pay bills for the Cathedral with no funds set aside for the engraving of the bricks. We are assiduously seeking a solution to this problem and I am committed to seeing the project through to completion, hopefully before the end of the year. Price quotes for engraving the bricks is around \$7,000. Interestingly, this number approaches the actual cost of a laser machine to do the work ... which we could purchase, do the work ourselves and then have the machine for other money-making projects.

The Egyptian Room is nearly finished but the entry way still has considerable work left. A special thanks is hereby sent out to Ill. Bro. Bob Hannon, 33° for a donation for lumber to continue the ceiling panels in the entry way. We are very interested in completing that effort as we've had a lot of interest in renting that space for Special Events.

Other work in progress includes the conversion of the church to a library. Bro. Bob Kille, 32° and I are building a gothic fan fault ceiling for it and expect the result to be spectacular (Google "Sherborne Abby Choir Ceiling images" to see approximately what it will look like).

The Tuesday Crew is back and continuing to assist in regular maintenance. They could use some more help so if you have a skill ... or want to develop one ... contact Bro. Arnold "Rusty" Rouse, 32°. He could use your assistance and it would be appreciated.

It's shaping up to be an unusually busy autumn and that means Special Events. Lynn will in need of volunteers to help set up for those special events and also for extra staff help during the event. She will be putting together a sign up system for you to volunteer.

Lynn is also working with Bro. Brian Pilz,  $32^{\circ}$ ,  $K \therefore C \therefore C \therefore H \therefore$  on Parking Lot staffing. We are offering our local Blue Lodge Brothers the chance to help work the lot and make some extra monies for their Lodge. Brian will have the details soon.

I know that there is much to do but we should all be proud of our preservation of the Cathedral. Many Scottish Rite Valleys are selling their buildings rather than assume the responsibility for the stewardship of Masonic architecture. The support of our Temple by the membership has been noticed and commented on around the Southern Jurisdiction and it could not be done without you

#### CALL TO ARMS

e hear it time and time again, another of our Fraternal groups begging for help...or money...or more members. It is easy for us to say, "I have done my service, it is time for others to step up." But do we ever reach a point when we have completed our service? Of course the answer is "NO." Our service is done when we at last lay down our working tools and stand before the Great Architect.

The Scottish Rite is no exception to this situation. The Valley of Tucson is always asking for help...or money...or more members. We have to, we not only have a significant membership of Scottish Rite members who count on our existence, we also have the Tucson Scottish Rite Cathedral which counts on our service and support. Nowhere in Arizona is there another building that celebrates our Fraternity quite the way that the Tucson Scottish Rite Cathedral does. We should be endlessly proud of our Cathedral and what it offers to Arizona Freemasonry and we must band together to help preserve it.

I want to congratulate all of our Brothers who have been invested with the Knight Commander Court of Honour at this year's Biennial Session. As you will soon see, the Investiture Ceremony for the Knights Commander Court of Honour is filled with lessons which reinforce the need for our continued participation.

In the opening remarks of the Lt. Grand Commander, he states of the  $K \therefore C \therefore C \therefore H \therefore$ : "It indicates that up to this time your conduct, zeal, and fidelity have been such as to mark you as faithful Scottish Rite Masons. Whether this opinion will prevail depends on a continuation or an increase exercise of those commendable qualities which have earned our of your past efforts..." During the Ceremony, the Grand Minister of State presents the recipients with the "Synthetic Badge". While these decorations are seldom worn, it does not mean that we can forget the symbolism they hold. We are informed that we "...are entitled to wear this badge as a trophy secured by days and nights of toil and service in Masonry."

Lastly the K :: C :: C :: H.: recipients are bound with "the belt of knighthood" by the Grand Commander. This belt is described as follows: "Sometimes it was the belt and the sword, which was given the postulant and sometimes the belt alone. It was to teach the knight that he must ever be ready to do battle for the cause in which he was engaged."

Our new K :: C :: C :: H :: members will learn these lessons but they apply to all of use. Therefore, I submit to you, my Brothers, that we must now go to battle! We must battle for our cause...of protecting Scottish Rite Masonry in the Valley of Tucson. We must battle for each other and our common way of thinking and acting. Most of all, I ask that we all battle entitlement and apathy. May we never feel that we are entitled to the honors which we have received merely on what we have accomplished in the past, but that we continue to earn them each and every day. Our service is not done...we need to continue to take an active role in our Valley!
